National Day of Service 2019



On January 15, 2019, National Day of Service was held at the Capitol. Senior Corps, AmeriCorps and VISTA directors and members had the opportunity to meet with Senators and House of Delegate members throughout the state.

Senator Greg Boso and Delegate Mick Bates introduced National Service groups during the legislative session.

Some interesting facts about National Service in West Virginia:

- Last year, Senior Corps volunteers served at more than 600 locations across West Virginia, including schools, food banks, homeless shelters, health clinics, and youth centers.
- Over 3,800 National Service volunteers serve West Virginia each year.
- Last year West Virginia received \$12.2 million in funding for National Service.
- Programs include: **AmeriCorps, VISTA, and Senior Corps.** Funding is provided by the Corporation for National and Community Service (CNCS), a Federal Agency.
- National Service programs support over 600 nonprofits, schools, and service agencies in West Virginia. They are the volunteers reading to children, teaching job skills, and the retirees giving back after a long career.
- In 2018, West Virginia ranked #1 in the Nation for producing AmeriCorps volunteers.
- Since 1994 over 13,000 West Virginians have served approximately 19 million hours in AmeriCorps and earned Education Awards totaling \$32.4 million.

MOVRC Loan Program Updates

MOVRC's EDA-RLF, the US Economic Development Administration Revolving Loan Fund, received a Risk Rating of A. The USEDA ranks the revolving loan program on an annual basis under 15 different criteria. The MOVRC EDA-RLF's rating of A is the best rating that can be awarded. Currently MOVRC's EDA-RLF has available to lend \$2.1 million dollars. Help us maintain our rating by promoting our lending programs to small businesses. We cover the entire state of WV with our various lending programs.
